#### **GOOD GOVERNANCE**

Supporting cities and municipalities to adhere to good governance principles, establishing Knowledge and Information Hub, developing and applying local regulations and policies, establishing local e-Government services and raising awareness about the benefits of good governance mechanisms.



#### **SOCIAL INCLUSION**

Strengthening local governments and organisations to develop and implement policies leading to the advancement of social inclusion and the improvement of social services, along with supporting citizens and civil society organisations (CSOs) to engage in local decision making.



# **GENDER EQUALITY**

Supporting local governments to establish and/or strengthen local Gender Equality Mechanisms and form Local Women Councillor Networks for the promotion of and advocacy for gender equality.


